

OFFICER WITNESS STATEMENT

On 12/3/13, at approximately 0840 hrs. Ptlm McNulty and I were dispatched to WPRO Radio for a threats complaint. While responding to the scene, we were advised by police dispatch that the suspect vehicle was a grey pick-up truck with two male occupants wearing hoodies.

Upon arrival, I searched the parking lot, but did not locate the vehicle. I was then approached by the victim identified as John Depetro (64). He stated that the truck was parked between the main and back parking lots next to a tree. Depetro stated that while he was walking into the building, he was looking down and heard someone call his name. Depetro looked up and saw a small grey pick-up truck with unknown plates with two males inside. The front passenger side window was down and Depetro stated that the driver was leaning over the front seat yelling: "Your fucking with the wrong people and we are going to knock you off the radio! Then we are going to knock your fucking head off because you have a big fucking mouth!" Depetro stated that he turned towards his vehicle and the driver said: "You want to do something?" Depetro looked back at the truck and saw that the passenger had something in his hand? Depetro stated that he then thought that someone was behind him and he ran back to his car. Depetro got in his car and looked back at the truck. He saw the truck exiting the parking lot onto the Wampanoag Trail. Depetro stated that he believed that the truck had Rhode Island plates on it with a trailer hitch on the back.

Depetro stated that he has recently been getting threats via email and Twitter. He believes that the threats are coming from a group of protester's that are against Gine Raimondo. Depetro stated that he made comments against the protester's a couple of weeks ago and since then, a web sight was developed from the group "For Our RI Daughters" showing Depetro as a monster towards women and depicts him as a sex offender. Depetro gave two names of people that may be behind the threats. They are Maureen Martin and Brad Default. Depetro stated that they may have had something to do with the development of the sight.

At this time I request that this case be forwarded to the Detective Division for further investigation.
