On 6-12-2015 at 1447 hrs Detective Rotella was advised of a 2nd degree sexual assault which occurred in the City of Providence on May 3rd, 2015 at the Westend Community Center. It was learned that on May 3rd 2015 while attending a basketball game, Coach Tyrone Dale DOB 2-13-1970, was with [REDACTED], in the gym. Shortly after his [REDACTED] left leaving coach Dale and [REDACTED] alone. [REDACTED] then stated coach Tyrone Dale pulled down [REDACTED] shorts exposing his penis. [REDACTED] then said at that point Coach Dale began stroking [REDACTED] penis. [REDACTED] went on to say that during the incident he felt intimidated and extremely nervous and took out his cellular telephone and video recorded the incident. On the cell phone recording Tyrone Dale is identified as the individual in the video.

Based upon the above facts police will be getting an arrest warrant for 2nd degree sexual assault in the name of Tyrone Dale.

Supplement (Det. Cute)

On 06/12/2015 suspect Tyrone Dale responded to Central Station to meet with detectives. Det. Cute escorted Dale to an interview room in the Detective Bureau where he was advised of his constitutional rights from a pre-printed form. Dale stated he understood his rights, signed the form and agreed to be interviewed. The interview was captured via audio / video.

Dale was asked about the incident with [REDACTED]. Dale stated he and [REDACTED] were in his vehicle, alone, when he looked over and noticed [REDACTED] exposed his penis. Dale stated he believed [REDACTED] was trying to set him up due to the fact that Dale knew certain secrets that [REDACTED] had. Dale stated he had no inappropriate contact with [REDACTED]. Detectives then showed Dale the cell phone footage of the incident. Dale identified himself in the video and acknowledged that his hand was holding Mangru's penis at one point. Dale further stated that although the footage looks bad he still maintains he did nothing wrong. The interview was concluded and Dale was escorted to the cell block area.

Tyrone Dale DOB 02/13/1970 was charged with one count of 2nd degree sexual assault (11-37-4). Dale was held for the next session of court.
