Case Narrative 14-101452

On Saturday October 11, 2014 at approximately 2329 hours Car 381 Ptlm. Kennedy was dispatched to 1 Orms Street (Providence Marriot), for a report of a larceny of a cellphone. Upon arrival police met with the complainant identified as Chelsea Moreira dob 06-21-1986 (401-419-2053, 401-688-5221). Moreira stated that she had entered the Marriot, just to use the ladies room. While Moreira was in the ladies room, she placed her blue Samsung Galaxy S4 cellular phone with purple case protector on the ladies room counter. Moreira stated that there were three females in the ladies room when she had gone in. Moments later Moreira left the ladies room and exited the front entrance of the Marriot. Moreira immediately realized that she had forgotten her cellphone on the ladies room counter. Moreira then responded back to ladies room and observed that her cellphone had been missing, from where she had originally left it. Moreira then responded over to the front desk, to ask if anyone had found her cellphone.

While Moreira was speaking with the front desk worker, she observed two of the females who were in the ladies room when she was initially there. Moreira walked over to the two females (who were outside the front entrance) and asked them if they knew about her missing phone. At which point one of the females stated "was it purple", "Delilah has it". The female subject went on to state "she's inside you can't miss her, she's very drunk and is wearing the black and white skirt". Moreira then responded back into the Marriot to locate Delilah. Moreira located Delilah and asked her if she had her cellphone. Delilah stated to Moreira "frisk me". A moment later a male subject wearing a grey suit and red dress shirt, later identified as David Sanchez dob 03-30-1989 approached the two females. Sanchez told Moreira to "calm down" as he handed her, the purple case to her phone. Sanchez then stated to Moreira "I just had your phone". Moreira asked Sanchez where the actual cellphone was and Sanchez stated that he didn't have it and then walked away from her.

As Moreira was still speaking with Sanchez, the Marriot security intervened with the two. Moreira then stated that a female Sergeant (Sgt. Michelle Guerette) who was wearing a black and white dress walked over to her and handed her a blue Samsung Galaxy S4 cellphone (without the battery).

Police then spoke with Sgt. Guerette and asked her where she had found the phone. Sgt. Guerette stated that Sanchez was the person who had handed her the cellphone. Police then spoke with Sanchez, who stated that he did not know how the phone got into his pants pocket. Police then spoke to Delilah Rivera dob 11-28-1984 and asked her if she had taken the cellphone. Delilah stated to police "sir I didn't take no cellphone from no one".

Car 300 Lt. Smith, Lt. Fernandes, Car 390 Sgt. Scanlon, were all on scene at this time. Police had Moreira fill out a written witness statement on scene. Police observed Moreira to be in possession of her described cellphone, minus the battery. Photos were taken of the cellphone on scene in Moreira's possession. It should be noted that the two females who described Delilah to Moreira, were not on scene when police arrived. This matter will be turned over to detectives for further investigation. No further information at this time.
